Call Your Legislators On These Important Reforms!

The California State Legislature
Reconvenes on August 18 To Consider
These Important Issues...

✗ SB 789 (Menjivar D-North Hollywood) Would require all owners of commercial property to register with the state and report annually on the percentage of their property that remained vacant so that local agencies could decide on whether to impose taxes and fees. CORONA Chamber **Opposed**, Bill Will Remain Under Consideration For Action Before 9/2026.

AB 735 (Carrillo D-Palmdale) Would require counties and cities to report truck routes to the state for enforcement by the CHP against property owners and trucking companies for driving decisions made by drivers. CORONA Chamber monitoring with concerns, Bill in State Senate Appropriations. Committee awaiting action in August.

PAGA Reform Update ... No Change In Number Of Suits Filed From 2024 ...

In 2024, the Governor, the Legislature, and others including the CalChamber announced strengthened employer defenses in a state led wage dispute lawsuit process commonly known as PAGA (Private Attorney General Actions) Unfortunately none of that has occurred with 9,488 suits filed in 2024 and over 5,480 suits filed so far this year with 27 CORONA employers served with suits in the last two years. **CORONA Chamber has met with all our legislators and urged more reforms are needed!**
